To Rent Or To Buy?

Renting Pros

- Flexibility to move around
- Maintenance costs on the owner
- No HOA fees (with the exception of Ecuador/Uruguay)
- Reduce upfront capital costs

Buying Pros

- Long-term investment
- Pay cash – no monthly payment
- Eliminate exchange rate risk
- Can generate cash flow
- It's yours

- ✓ Use An Attorney

- Local Real Estate Agencies
- Local Papers
- Local “For Rent” Signs
- Word Of Mouth

Buying Checklist

- ✓ Location
- ✓ Carrying Costs
 - HOA Fees
 - Property Taxes
 - Utility Costs
 - Insurance
- ✓ Use An Attorney

Things Work Differently

- No MLS
- Real Estate Agents
 - Not necessarily licensed
 - Generally don't cooperate with other agents
- Net Commissions
- Use An Attorney

The Real Cost Of Buying

- Transfer Taxes (Stamp Duty)
- Registration Fees
- Agent Fees
- Legal/*Notaire* Fees
- Property Taxes
- Homeowner's Association Fees

Titling Options

- Individual Name
- Joint Tenants with Rights of Survivorship
(not available in all jurisdictions)
- Local Corporation
- Foreign Corporation
- Inheritance Laws
